## **CONDITIONAL GRANT AGREEMENT**

### **2017/2018 GROUND SEARCH AND RESCUE PROGRAM**

**BETWEEN: HER MAJESTY THE QUEEN** in Right of the Province of Alberta as represented by the Minister of Municipal Affairs ("the Minister")

**WHEREAS** the SAR Group plans to participate in a project to enhance the delivery of ground search and rescue training throughout the province, and has applied to the Minister for a conditional grant in order to obtain financial assistance to carry out the project.

**AND WHEREAS** the Minister has approved the SAR Group's application and has agreed to make a conditional grant to the SAR Group pursuant to Schedule 1 of the Municipal Affairs Grants Regulation.

The parties agree as follows:

1. The Minister shall:

- (a) subject to the provisions of this Agreement, pay the SAR Group a one time conditional grant of Seven Thousand Seven Hundred DOLLARS (\$7,700.00) (the "Grant") in order to carry out a project under the 2017/2018 Ground Search and Rescue Training Program, as further set out in the Grant Application, attached as Schedule "A" and forming part of this Agreement (the "Project");
- (b) provide the Grant by lump sum payment to the SAR Group after receipt of two signed copies of the Conditional Grant Agreement;
- (c) have the right to conduct an evaluation or audit of the Project at any time; and
- (d) have the right to publish and distribute any report submitted by the SAR Group to the Minister on the Project.

2. The SAR Group shall:

- (a) carry out the Project set out in Schedule "A" without material alteration;
- (b) complete the Project and use the Grant by May 31, 2019;
- (c) use the entire amount of the Grant for the purpose of carrying out the Project;
- (d) pay any additional costs required to complete the Project if the total costs exceed the Grant;
- (e) not use any part of the Grant to pay for training carried out or materials obtained before this Agreement came into effect;
- (f) only use the allocated amounts for the purpose of carrying out the specific components identified in 1(a) above;



- (g) submit Reporting Documents to the Minister by June 30, 2019, after completion of the Project to certify that the funds were used for the Project and within the time limit specified in 2(b);
  - (h) conduct the Project in accordance with all applicable laws, regulations and generally accepted standards; ensure that all personnel involved with the Project are suitably qualified; and
  - (i) repay the Minister of Finance all or any portions of the Grant demanded by the Minister in the event of any noncompliance with this Agreement by the SAR Group, or if the eligible costs of the Project are less than the amount of the Grant.
3. The SAR Group represents and warrants to the Minister that the execution of this Agreement has been duly and validly authorized by the SAR Group in accordance with all applicable laws.
  4. If the SAR Group does not meet all of its obligations under this Agreement or uses the Grant or any portion of it for any unauthorized purpose, the Minister will notify the SAR Group of such breach in writing and the SAR Group will have 20 days to remedy such breach. If, in the opinion of the Minister, the SAR Group does not remedy the breach, the Minister may terminate the Grant or any portion of it, without further notice to the SAR Group, and demand the immediate return of the Grant, or such lesser amount as the Minister may determine, to the Government of Alberta.
  5. The Minister may terminate this Agreement for any reason by notifying the SAR Group in writing upon 60 days notice. Upon receipt of the notice of termination, the SAR Group shall only use the Grant to pay reasonable wind-down costs and committed expenses related to the Project. Immediately upon termination of this Agreement, the SAR Group shall refund to the Government of Alberta any unexpended portion of the Grant and any amounts expended for purposes other than those specified in this Agreement.
  6. (a) This Agreement shall come into effect on the date that the Minister or his representative signs this Agreement.  
(b) This Agreement shall cease to be in effect on the date that all provisions of this Agreement have been met by the SAR Group, unless terminated earlier by the Minister in accordance with this Agreement.
  7. Amendments to this Agreement, including changes to Schedule "A", may be necessary from time to time and may be initiated by the Minister or the SAR Group in writing and shall be agreed upon by both parties.
  8. The Minister and the SAR Group acknowledge that the *Freedom of Information and Protection of Privacy Act* (FOIP) applies to all information generated, collected or provided under this Agreement and will comply with its provisions.
  9. The SAR Group will indemnify and hold harmless the Minister, his employees, servants and agents against any claim, demand, action, suit or proceeding that may at any time be brought against the Minister, his employees, servants or agents arising out of the use of the Grant or the performance or non-performance of this Agreement.
  10. This Agreement, including Schedule "A", is the entire agreement between the Minister and the SAR Group with respect to the Grant from the Minister for this Project. There are no other agreements, representations, warranties, terms, conditions or commitments except as expressed in this Agreement.

11. The following clauses shall survive conclusion or termination of this Agreement:
- a) FOIP – Clause 8;
  - b) Indemnity – Clause 9; and
  - c) Entire Agreement – Clause 10.
12. This Agreement shall not be assigned without the express written consent of the Minister.
13. The rights, remedies and privileges of the Minister under this Agreement are cumulative and any one or more may be exercised.
14. Any notice under this Agreement shall be deemed to be given to the other party if in writing and personally delivered, sent by prepaid registered mail, sent by facsimile transmission, or emailed to the addresses as follows:

17. If any portion of this Agreement is deemed to be illegal or invalid, then that portion shall be deemed to have been severed from the remainder of this Agreement and the remainder of this Agreement shall be enforceable.




18. In the event of any conflict between the terms of this Agreement, the conflict shall be resolved according to the following order of priority: the Clauses of this Agreement and Schedule "A".




