Thank you for your email response of February 14. We would like to proceed with gaining administrator access to the Pincher Creek Search and Rescue Page at http://www.facebook.com/229623653868184.

Please find attached a copy of my Alberta driver's license, as signer of this statement. As President of the Pincher Creek Search and Rescue Society, I have sufficient knowledge and authority over this matter. This statement is being delivered to you, signed and notarized. As requested, I include:

"a) A description of your relationship to the Page (and authority to request a change in the person(s) who manage the Page, as applicable);"

I am the President of the Society for which the Page was created. I am authorized to represent the Society, and to request a change in the person who manages the Page.

"b) The name of the current person(s) who manage the Page, as applicable;"

The page was created by Ms. Alieza Cyr, a former volunteer with the Pincher Creek Search and Rescue Society. It is our belief that Ms. Cyr continues to currently manage the Page.

"c) The relationship of the above person(s) to the Page;"

Ms. Cyr was a member of the Society represented by the Page at the time the page was created. Since January 1, 2017 she is no longer a member of the Society, and is not authorized to manage the Page.

"d) An explanation of your request, and whether there has been a termination of the employment and/or business relationship with the named person(s), as applicable;"

The Page was created originally by Ms. Cyr, a member of Society. On January 1, 2017 Ms. Cyr ceased to be a member when she no longer met the requirements set out by the Government of Alberta for members of Search and Rescue organizations. At this point the Society's relationship with Ms. Cyr was terminated. We've made several attempts to contact Ms. Cyr to have Administrative rights on the Page transferred. She has not responded to any of our requests.

"e) All documentation supporting your request;"
