**AMENDING CONDITIONAL GRANT AGREEMENT**

BETWEEN:

**HER MAJESTY THE QUEEN IN RIGHT OF ALBERTA,**  
as represented by the Minister of Municipal Affairs  
(the "Minister")

-and-

**PINCHER CREEK SEARCH AND RESCUE SOCIETY**

BACKGROUND:

- A. The parties entered into a Conditional Grant Agreement dated April 6, 2020 whereby the Minister granted to the Pincher Creek Search and Rescue Society Five Thousand Four Hundred DOLLARS (\$5,400.00) (the "Agreement").
- B. The Agreement states that the Pincher Creek Search and Rescue Society shall complete the Project, and use the grant, including any income earned by May 31st, 2021.
- C. The parties have agreed to extend the term of the Agreement to October 30, 2021.

The parties agree to amend the Agreement as follows:

1. Clause 2(b) of the Agreement is amended by deleting "May 31, 2021" and inserting "October 30, 2021."
2. Clause 2(g) of the Agreement is amended by deleting "June 30, 2021" and inserting November 30, 2021."
3. Schedule A to this Agreement is amended by deleting a reference made to the "Date training to be held" as stated in the page 4 titled "Project results/proposed training plan", attached as and forming part of Schedule A, and replacing such "Date training to be held" with the following date for the training course:

1. SAR searcher Course	October 15, 2021


4. Except as amended by this amending agreement, the Agreement shall continue to be in effect.
