FACILITY AND SERVICE AGREEMENT

BETWEEN:

ALBERTA BINGO SUPPLIES LTD. carrying on business as CASINO LETHBRIDGE (hereinafter referred to as "ABS")

-and-

PINCHER CREEK SEARCH & RESCUE SOC. **BOX 1094** PINCHER CREEK, ALBERTA **TOK 1W0**

(Hereinafter referred to as "the Licensee")

THE PARTIES HERETO HEREBY MUTUALLY COVENANT AND AGREE AS FOLLOWS:

PREMISES A.

ABS hereby leases to the licensee, and the licensee hereby accepts such lease from ABS, the premises of ABS (as hereinafter defined) at a fee hereinafter established and agreed upon, for the purpose of conducting a casino during those times and on those dates when the Licensee shall NEXT be granted a license by the Alberta Gaming & Liquor Commission (hereinafter "the Commission") to operate a casino in Lethbridge, Alberta. Such casino is hereinafter referred to as "the Casino".

As used herein, the premises of ABS shall mean 3756 – 2nd Avenue South, Lethbridge, Alberta T1J 4Y9. 2.

FEE B.

The fee payable to ABS for leasing the premises hereunder for a two day casino event shall be:

65% of the table games net win (excluding craps and poker) or \$16,000.00, whichever is the lesser amount, plus 35% of the GST

POKER: \$1,400.00/table/day plus \$100.00/hour/table/day for each additional hour of operation outside the basic casino hours to a on the applicable fee payable thereon. maximum of \$1,700.00/table/day. The fee cannot exceed 75% of the total table rake per table.

EQUIPMENT AND FACILITIES C.

In consideration of the fee payable hereunder, ABS shall provide to the Licensee, for the Licensee's use in the conduct of the Casino, the following: Casino equipment and services (14 table games, playing cards, chips and cash float); casino staff (games manager, pit staff, dealers and monitor room personnel); security services (guards, armored car, safe combination change, hold up / robbery Insurance and CCTV camera surveillance); and advertising.

MISCELLANEOUS D.

The licensee understands and agrees that ABS may, in ABS's sole discretion, elect to conduct a tournament during the Casino in accordance

All forms of money payable to ABS hereunder shall be paid by the AGLC forthwith upon completion of the Casino from the casino revenue.

The performance of the within agreement shall be subject to the rules and regulations as set forth from time to time by the Commission. If ABS is prohibited from performing as specified as a result of amendments to the Commission's rule ad regulations, ABS shall be deemed to 2. have satisfied its obligations hereunder so long as ABS complies with the amended rules and regulations of the commission.

The provisions of this agreement shall be valid and binding upon the parties and their successors or assigns, and time shall be of the essence.

This is the entire agreement between the parties.
